Carthorpe Signs - JJ advised that following the verbal construction quote of £2450 + VAT, this had failed to be received in writing. The Calvert quote for stone is £530/sign. Estimated total costs for 3 signs is £4k. It was felt that the stone was costly and may incur costly repairs if damaged. Suggested that brick may be cheaper and more relevant to the history of the village with the Mires brickworks. All agreed. Costs to be further investigated.
