


DECLARATION OF ACCEPTANCE OF OFFICE

3. The completed Declaration must be handed to the Proper Officer of the Parish / Town Council for his / her retention immediately after completion.
4. If a member of a Parish / Town Council fails to comply with 1 and 2 above, their office shall become vacant.
