24.51 Apologies for Absence

24.52 Declarations of Interest

24.52.1 There were no declarations of interest.

24.53 Minutes of Previous Meeting

24.53.1 The minutes of the meeting of 22 July 2024 were approved and signed as correct.

24.54 Matters Arising

24.55 Finance

24.55.1 *Receipts & Expenditure*

A brief summary of the financial situation was given. £6894.82 closing balance of which £4673.13 remains in Precept and £2221.69 in CIL funds.

24.55.2 Barclays Savings Account

Total stands at £415.15 following an interest payment of £1.55.

24.55.3 Asset Register

JJ asked the meeting for opinions on asset values. A discussion took place, and JJ undertook to update the asset register with replacement values. A new quotation is then to be requested from insurers for full replacement costs.

24.55.4 Precept 2025-26

The meeting agreed to wait until after The Budget (30 October 2024) before setting the Precept for 2025-26.

24.56 Planning

24.56.1 ZB24/01253/FUL - Victorian Studio, Carthorpe – retrospective application for patio doors and fencing plus entrance door/glazing. This application was Refused and had gone to Appeal.

ZB24/01710/FUL - Victorian Studio, Carthorpe – retrospective application for patio doors, wall and screen plus entrance door/glazing.

JJ advised that the second, revised application had been received and summed up the contents. Local Residents were invited to put their points across to the meeting.

In summary:-

*The Curtilage drawing in the application was still believed to be incorrect. The Public Footpath and NYC verge having been omitted.

*The PC believed that the alterations already made, and now proposed along the eastern boundary, should not constitute the removal of Condition 2 from the original 1990 Planning Approval. A more detailed response to be drafted and submitted to NYC and will be available for viewing on the planning website as a matter of public record.

24.57 **Councillor Report**

24.57.1 DW reported that the NYC staff restructuring was nearly complete. A staff survey had shown that the majority were happy with this restructure. The NYC budget currently showed a £40M deficit and this was expected to rise to £48M in the near future. North Yorkshire has a Government target of 4,232 new homes to be built across the county each year. Currently 3000 new homes are being built annually. NYC is concerned that labour and materials will not be available to meet the target. NYC was currently working on the 'Local Plan'. There was also an ongoing leisure review looking at ways to harmonise leisure delivery county wide.
